REQUEST FOR EXPRESSION OF INTEREST (EOI)

FOR

RENDERING CONSULTANCY SERVICES FOR THE REFORM OF BPDB AS A CORPORATE BODY IN LINE OF PETRO BANGLA

1.0 Introduction:

(A) Bangladesh Power Development Board (BPDB) is in a process of selection of a Consultant for a recommendation in order to reform BPDB in a corporate body in line with Petro Bangla of Bangladesh (National Petroleum Corporation). The major job is to assess the asset and liability, determining present value at asset, working principle of corporate body with required adjustment BPDB's procedure, man power requirement and a comprehensive recommendation that need in line with desired goal. Also consider the responsibility and functionality BPDB that has to reform as generator, single buyer and maintaining distribution activity.

2.0 Scope of Services in brief:

Study the Corporate Structure of Petorbangla and application of that in BPDB in the light of BPDB's role in the power sector:-

- (i) Study of Corporate Structure of Petrobangla and suggest adaptation policy into BPDB
- (ii) Study the Consumer mix of different distribution zones and suggest the bulk purchase tariff from BPDB.
- (iii) Development of organogram of different distribution zones.
- (iv) Determine the necessary support to be provided centrally from BPDB.
- (v) Relation between BPDB & Corporate body
- (vi) Legal & financial relation between BPDB and Corporate bodies.
- (vii) To suggest about mode of selection & appointment of Board of Directors & Senior Employees.
- (viii) Nature of autonomy of Corporate bodies.
- (ix) Responsibility and accountability of Corporate bodies and BPDB.
- (x) Determine the asset & liability including DSL of different Corporate bodies.
- (xi) Financial Management of O & M & Project Financing.

3.0 Eligibility:

(C) Interested applicant should have experience of Reformation/Re-structuring activity in Govt./Public/Private Sector in similar consultancy services as Management Consultant.

Otherwise EOI from a Association/ Joint Venture will not be considered for Short-listing

- 8.1 Each page of the documents submitted shall be duly authenticated by the applicant.

8.2 The language of submission of applications shall be in English.

8.3 Financial Data, Project Costs, Value of works shall be given in US Dollars only.

9.0 Evaluation of EOI:

Evaluation of EOI (Short listing of Consulting Firms) will be done on the basis of:

(a) brochures submitted by the Applicants summarizing their facilities and areas of expertise;

(b) descriptions of similar assignments;

(c) experience in similar operating environments and conditions;

(d) availability of appropriate experience and professional qualifications among Applicant's staff and adequate resources to carry out the assignment; and

(e) managerial strength and financial capacity.

BPDB reserves the right to accept any or reject any/ all EOIs without assigning any reason thereof.
